- 8. Meeting adjourned at 7:00 pm.


Rural Municipality of Kinkora Notice of Public Meeting Changes to Official Plan and Zoning and Subdivision Bylaw

Take notice that pursuant to the Planning Act and the Rural Municipality of Kinkora's Official Plan and Zoning and Subdivision Control (Development) Bylaw, Council will hold a Public Meeting, Monday, April 23, 2018 at 6:30 pm at the Community Centre, 45 Anderson Street, Kinkora.

The purpose of the meeting is to allow residents and other interested persons an opportunity to review and make representation concerning the following amendments to the Rural Municipality of Kinkora's Official Plan and Zoning and Subdivision Control (Development) Bylaw:

- To change PID#s 1080811, 1080829 and 1080837, McGuigan Lane,
 Somerset Estate Subdivision from (R3) Multiple Family Residential Zone to
 (R4) Multiple Family Residential Zone to allow for two tri-plex buildings.
- To change PID# 465385, intersection of Somerset Street and Anderson Road from (R2) Single Family Residential Zone to (C1) General Commercial Zone to allow for a Dairy Bar.
- To amend to the Official Plan Concept Plan for Future Land Use Map in order to accommodate the above noted changes.
