

**Rural Municipality of Kinkora, PEI
Inter-Municipal Agreement Bylaw
Bylaw # 2021-03**

BE IT ENACTED by the Council of the Rural Municipality of Kinkora as follows:

1. Title

- 1.1. This bylaw shall be known and cited as the “Inter-Municipal Agreement Bylaw.”

2. Purpose

- 2.1. The purpose of this Bylaw is to allow the Rural Municipality of Kinkora to enter into an agreement with another municipality of offer service(s) as outlined in Section 180 of the *Municipal Government Act* R.S.P.E.I. 1988, Cap. M-12.1.
- 2.2. The Rural Municipality of Kinkora enters into an agreement with the Rural Municipality of Bedeque for emergency measures services as outlined in the attached Appendix A.

3. Authority

- 3.1. Pursuant to Section 138 of the *Municipal Government Act* R.S.P.E.I. 1988, Cap. M-12.1., power to enter into agreements with another municipality, if authorized by bylaw, with another council for the provision of service which each has the power to provide within its own boundaries.
- 3.2. An agreement referred to in subsection (1) shall be in writing and shall set out the terms and conditions that apply to the agreement. *2016,c.44,s.138*.

4. Effective Date

- 4.1. This Inter-Municipal Agreement Bylaw, Bylaw# 2021-03, shall be effective on the date of approval and adoption below.

First Reading:

Second Reading:


This Inter-Municipal Agreement Bylaw, Bylaw# 2021-03, was read a second time at the Council meeting held on the 27th day of September, 2021.

Appendix A

The Rural Municipality of Kinkora is entering into an agreement with the Rural Municipality of Bedeque to share an Emergency Management Plan. This plan is required under Section 145 of the MGA, Emergency Measures Plan and Program (1) Despite that section 8 of the Emergency Measures Act does not require it, a council shall, by bylaw, establish an emergency management program for the municipality that, in the opinion of the provincial Emergency Measures Organization, is adequate and properly integrated with the provincial emergency measures plan.
